100.35.01 Purpose

To establish standards for the minimum staffing of EMS personnel reflective of the most current operating budget allowances.

100.35.02 General

It is the responsibility of management and supervisors to ensure that minimum staffing levels are maintained daily with the appropriate level of certified personnel and accurately accounted for on the duty schedule

100.35.03 Minimum Daily Staffing Standards

1. The following listed stations shall be adequately staffed as indicated with the appropriate level of personnel. All other assignments and shifts do not require backfill.
2. Refer to *EMS Division Open Shift Scheduling, SOP 101.11* for fulfilling staffing requirements.
