Bill 2024-07 (ZTA 23-176) and Bill 2024-08 (ZMA 23-02)

Aviation Business Park Zoning District

Bill #2024-07 (ZTA #23-176) and Bill #2024-08 (ZMA #23-02) are meant to promote economic development and permit development that is compatible with the Maryland Airport. Certain provisions of the Charles County Zoning Ordinance would be amended by ZTA #23-176, creating the Aviation Business Park (ABP) Zone as a new base zoning district. The Charles County Zoning Maps would be modified by ZMA #23-02 to rezone some properties near the airport to the new ABP Zone, with some properties along Ray Drive rezoned to General Industrial (IG). **The County Commissioners are holding a second Public Hearing on October 29, 2024 to consider these proposed Amendments, which have been revised after feedback was received from previous Public Hearings with both the Planning Commission and the Board of County Commissioners.
