

PARTIAL RELEASE DEED OF TRUST

THIS PARTIAL RELEASE DEED OF TRUST made this ____ day of _____, 20____, by and between _____ (“Lienholder”), and _____, (“Borrower”).

WHEREAS, by Deed of Trust and Security Agreement (the “Deed of Trust”) dated _____, and recorded among the Land Records of Charles County, Maryland in Liber _____, folio _____, Borrowers conveyed to Trustee property identified as, Lot _____ in a Subdivision known as _____ as per plat thereof recorded among the plat records of Charles County, Maryland in Plat Book _____, folio _____; and further described in the Deed recorded among the Land Records of Charles County, Maryland in Liber _____, folio _____, (the “Property”), as described and more particularly set forth in the Deed of Trust.

TO HAVE AND TO HOLD unto Borrower, its successors and assigns, forever released and

discharged from the lienholder, operation, and effect of the Deed of Trust.

The partial release of the Released Parcel shall not affect in any way the lien, operation or effect of the Deed of Trust on the remainder of the land therein conveyed and not released hereby. The Deed of Trust shall remain in full force and effect as to the balance of the land not hereby expressly released.
