
To continue providing our students with a rigorous and high-quality education, I respectfully request your support for the proposed recordation tax increase. As presented by Mr. Jake Dyer on May 7th, this increase is projected to generate an estimated \$4.3 million, specifically slated to support the CCPS FY26 budget request. We want to ensure that this recordation tax is in addition to the funds already being allocated and approved for CCPS. These additional resources will enable us to maintain essential programs, support our dedicated educators, and ensure our students receive the comprehensive education they deserve in an increasingly competitive academic landscape.

Without these essential funds, CCPS will face significant operational challenges that will directly impact our students. The funding shortfall could compromise critical student programs, including summer school opportunities, and may necessitate further increases in class sizes. Additionally, we may be forced to renegotiate transportation contracts and face substantial shortfalls in our special education budget, potentially affecting our ability to serve our most vulnerable students.

The County's community budget survey has demonstrated strong public support for education funding. Based on this community mandate and the critical needs outlined above, we respectfully request your vote to approve the proposed recordation tax increase.
