**7.a Horizon Neighborhood, Revision #2, PLREV-250006**

Staff summarized the Applicant's request for approval of a revision to the approved Preliminary Subdivision Plan for Horizon Neighborhood. 10. **New Business:**

**10.a Briefing to set a date for a Public Hearing, Zoning Text Amendment (ZTA) #25-187, Data Centers**

Staff briefed the Planning Commission on an upcoming proposal for a Zoning Text Amendment to define, and permit with conditions, a new land use designated as 7.01.130, Data Center, in the Business Park (BP), General Industrial (IG), Heavy Industrial (IH), Low Density Residential (RL), and Planned Unit Development (PUD) Zones designated as industrial. Staff then answered several questions from the Planning Commission and requested to have the matter scheduled for a Public Hearing.

A **MOTION** was made by Mr. Bossart to schedule a Public Hearing for November 17, 2025, which was **SECONDED** by Ms. Hackett. The vote was unanimous, and the **MOTION** passed.

**10.b Zoning Text Amendment (ZTA) #25-189, Flexibility for Accessory Dwelling Units**

Staff briefed the Planning Commission on an upcoming Zoning Text Amendment to modify the existing Charles County Zoning Ordinance regulations to expand and modernize accessory dwelling allowances for both single-family attached and detached housing types. Staff answered several questions from the Planning Commission. A Public Hearing will be scheduled for a later date.

The clerk polled the Planning Commission for any new business they wished to raise. There was none.
