Presentation on Community Engagement & Website Development

Key Points:

- Discussion on past, present, and future engagement strategies in Charles County.
- Need for increased resident involvement and investment in government initiatives.
- Overview of the IAP2 Public Participation Model for engagement (Inform, Consult, Involve, Collaborate, Empower).
- Introduction of Stay Engaged Charles County, a new platform for gathering community feedback.
- Importance of a dedicated website for CJCC to improve accessibility and transparency.
- Presentation encountered technical issues, but key points were conveyed successfully.

Budget Discussion for FY26

Presented by: Deborah Zrioka

Proposed Budget Requests:

- Juvenile Justice Critical Intervention Mapping Study (\$35,000)
- Increase in-person meetings & community outreach costs (Food, materials, etc.)
- CJCC website and media campaign (Printing, marketing)
- Employee education & conference attendance (National CJCC Conference 2025)
- Training and workshops (On specific criminal justice topics)
- Pretrial Services Funding (\$355,400 requested; acknowledged as insufficient, requiring future discussions)

Key Points:

- CJCC is still developing a long-term pretrial services budget and will need more funding.
- Commissioner President Collins acknowledged that statewide budget reductions might affect funding but emphasized the importance of pretrial services for Charles County.



Charles County CRIMINAL JUSTICE COORDINATING COUNCIL

Open Discussion & Future Planning

Judge H. James West's Update on the Circuit Court

- Increase in foot traffic and security screenings (10,000+ monthly).
- Expansion of voir dire (jury selection process), potentially increasing trial lengths.
- Request for an additional judge position, currently under review.
- Challenges with courthouse infrastructure—expressed need for a new courthouse.

CJCC Legislative Advocacy

- Commissioner President Collins suggested developing an annual legislative report for policy discussions in Annapolis.
- Judge West supported creating a standardized format for yearly reports to better inform legislators.
- Deborah Zrioka has begun gathering examples of CJCC annual reports to establish a template.

Retirement Announcement - Deborah Zrioka

- Judge West announced that Deborah Zrioka will retire on January 17, 2025.
- Commendations:
 - Recognized for dedicated service in establishing and advancing the CJCC.
 - Played a critical role in courthouse operations, crisis management, and strategic planning.
- Deborah Zrioka's Statement:
 - Plans to take a brief break but will remain engaged in justice-related initiatives.
 - Expressed gratitude to colleagues and leadership for their collaboration over the years.
