### **Presentation on Emotional Trauma and the Brain**

Speaker:

- Sue Radcliffe, Mental Health Therapist, Maryland Department of Health

Key Points:

- Presentation focused on the effects of emotional trauma on brain function, particularly in relation to the criminal justice system.
- Key discussion points:
  - How trauma impacts the brain, particularly the limbic system.
  - The effects of stress and trauma on memory recall.
  - The importance of understanding trauma responses in victims, first responders, and individuals involved in the justice system.
  - The role of secondary and vicarious trauma for justice professionals.
  - Trauma-informed care and strategies to mitigate long-term effects.
- Ms. Radcliffe agreed to share her slides with the committee for further review.
- A follow-up video on trauma-related epigenetic changes was offered to be shared with the committee.
