Meeting Minutes

Meeting convened at 8:00 a.m.

Judge West opened the meeting, noting he would depart early due to a scheduling conflict and that Judge Donine Carrington-Martin would be available to help address questions. Commissioner President Collins confirmed attendance.

Judge West confirmed quorum by asking if all members had received and reviewed the agenda and prior meeting minutes.

The Meeting Minutes from the March 6, 2025, CJCC Meeting were approved.

Approval of Previous Meeting Minutes

- The March 2025 meeting minutes were emailed to all CJCC members.

- Outcome: Approved unanimously.

Presentation on Critical Intervention Mapping and Action Planning Workshop

Speaker:

- Dr. Kathleen Kemp, Associate with the National Youth Screening and Assessment Partners (NYSAP)

Sara Carruth introduced Dr. Kemp, highlighting her experience in juvenile justice, behavioral health screening, and cross-systems mapping, including prior work in Maryland with the Sequential Intercept Model (SIM).

Key Points:

- Overview of Critical Intervention Mapping (CIM), modeled on the adult Sequential Intercept Model.
- Emphasis on cross-system collaboration (juvenile justice, behavioral health, child welfare, education, social services).
- Workshop goals:
 - Mapping local systems, identifying strengths, gaps, and resources.
 - Establishing community-driven priorities for change.

- Developing actionable strategic plans.
- Importance of diverting youth from the juvenile justice system where safe and appropriate.
- Noted challenges: silos, funding constraints, communication barriers.
- Workshop outcomes: living maps and reports to guide ongoing strategic planning.

Discussion:

- Jason DuBard shared insights from attending prior SIM workshops, emphasizing the need to break down silos and improve awareness of existing resources.
- Julie Walton raised the importance of engaging families, especially given rising conflict between youth and caregivers. Dr. Kemp affirmed that family-based interventions and educating families about resources are critical components.
- The Juvenile Justice Committee will discuss workshop logistics at its upcoming meeting.
