**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

**Definitions.**

- (1) **High-Performer PHA** - A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

For Ports, only the additional 30-day extension to the sending HA's original voucher will be given. Tolling language has been updated to more clearly explain the tolling process. EID-Earned Income Disallowance has been discontinued per the recent Housing Opportunities Through Modernization Act guidance. Payment Standards-The process of updating and implementing Payment Standards has been updated to provide more details. Inspections-When an inspection fails at the 30-day recheck, a Housing Assistance Payment Program termination notice will be sent to the participant and landlord. Within the past five years, the HA assisted over 400 new households, exceeding the set goal. The HA utilized all budget authority for the program for the most recently completed year while special purpose vouchers for foster youth, however, were returned to HUD due to lack of referrals from the social services department who requested the vouchers. In the last 5-Year Plan, opening the waiting list was set as a goal. The HA reopened the waiting list for a limited period three separate times within the last five years. The waiting list was opened in 2020, 2021, and 2023.</b></p>
