Vehicles with a gross weight of 10,000 lbs. or greater must weigh in before 3:00 p.m.

Residential Flat Rates:

Car/Van/SUV	\$5 per load
Pick-Up Truck	\$15 per load
Vehicles w/trailer Weigh In	\$75 per ton/\$15 min fee
Yard Waste and Scrap Metal	FREE/advise clerk of material

Tag-A-Bag \$2.25 per 32-gallon capacity

*Non-hazardous waste that fits within a 32-gal trash can;
Diameter 22" Height 27"*

Commercial Vehicle Bulk Rates:

\$15 minimum charge

Commercial vehicles classified by: *Out of County ID, Vehicles with Trailers, Ladder Racks, Side Boards, Stake/Utility Body, Box Truck, Signs, Logos/Lettering, Business Check or Credit Card*

Bulk Waste \$75 per ton/\$15 min fee

Commercial Vehicle Recycling Bulk Rates:

Clean Soil	\$0 per ton
Scrap Metal	\$10 per ton
*Yard Waste	\$30 per ton

**Dump Trailers/Uniformed Crew/Loaded Lawn Equipment are considered commercial yard waste haulers.*

Scrap Tires Fees:

On or Off Rim, Bias, and Radial

Charles County residents can dispose of two (2) tires per visit at no charge. Additional tires must go over the scales.

10+ Tires	\$200 per ton
Farm Tractor/Off Road	\$200 per ton
Car/Pick-Up Truck	\$2 per tire
Dump Truck/Tractor Trailer	\$10 per tire

Landfill and Piney Church Mulching Facility hours to be reduced

The Charles County Landfill and Recycling Centers are working to protect staff and the public by reducing their operation hours during the COVID-19 pandemic. The Charles County Landfill and the Piney Church Mulching Facility operating hours will be 9:30 a.m. to 3:30 p.m. starting Saturday, March 21. Trucks weighing over 10,000 pounds will not be allowed to enter the landfill after 3 p.m. The Recycling center hours will remain unchanged. The Environmental Resources Division will continue to monitor the situation and modify the hours as needed.

Waste disposal is a critical public health essential service and the Environmental Resources Division is asking patrons to help reduce the COVID-19 pandemic impact to trash haulers, employees, and citizens. The following precautions are encouraged to help reduce transmission and exposure to employees and the public:

Delay spring cleaning: Please reduce the number of visits and when possible limit trips to drop-off spoilable or household waste only.

Self Service: All landfill and recycling center employees will be practicing social distancing to protect themselves and residents. Please be prepared to self-unload your vehicle, bring assistance if needed.

Bag Waste: When self-hauling household and spoilable waste, please make sure items are bagged. This will reduce the exposure of waste to employees and help prevent cross contamination to other patrons.

Hire a Hauler: When possible, residents are encouraged to hold bulk items or utilize a curbside collection service.

Skip Saturday afternoon: Visit outside of peak hours. The landfill is no longer able to provide an express lane on Saturdays.

Limit your transaction: Bring your own pen, pay with exact change, or write a check.

Prewrite your check: Checks must include the driver's license number, date of birth, expiration date, and valid phone number.

These recommendations are made to help minimize potential exposure to employees and residents. Your cooperation and concern for fellow residents and the employees of Charles County is appreciated during this time.
