





Community Services:	<p>Working with and supporting DES to coordinate calls with the MD Foodbank regarding the additional needs for local foodbank services for the County.</p> <p>DCS Housing Authority staff are actively processing expedited changes in monthly Housing Assistance Payments (HAP) for current housing choice voucher clients who have experienced a loss of income. Tenants on the HCV program simply need to contact the Division to notify their designated worker of a documented change/loss of household income and the Specialist will work with them to adjust their HAP payment amount.
