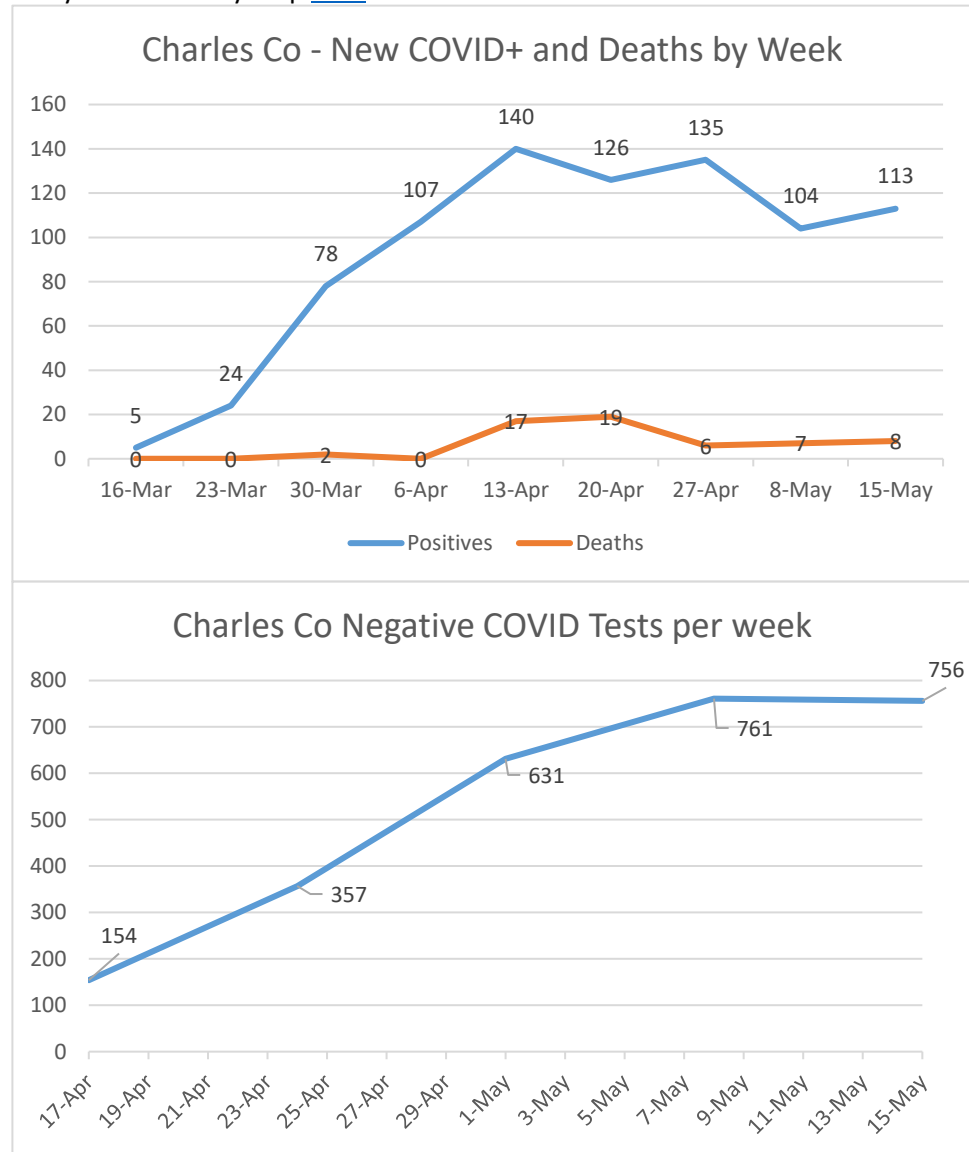

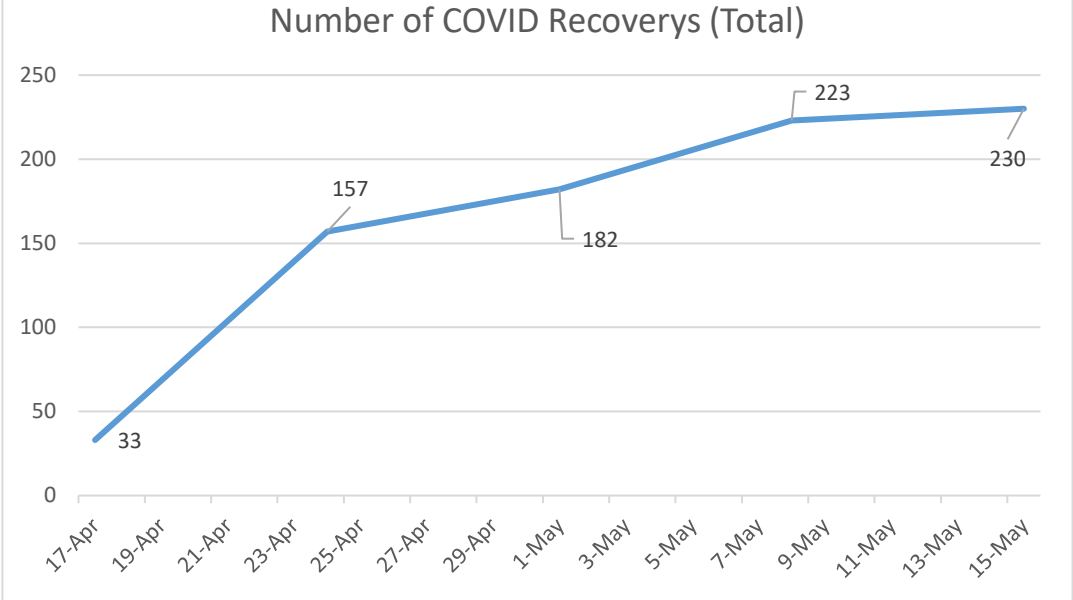

The very first column asks, "Are you able to screen students and employees upon arrival for symptoms and history of exposure?" If the answer is "NO", then unable to open. For CCPS that would be screening approximately 30,000 people daily.</i>
