Justification for New Fees

- 3, 5, & 6 These fees are in addition to the base Board of Appeals fees to support the amount of review time taken in the review of Special Exceptions and Variances in the Critical Area. These cases included a separate set of criteria/findings that must be achieved to move forward. Additionally, close coordination with the Critical Area Commission is required by State law. On average, the review time for Critical Area Program compliance for these items is 6 FTE hours for the first review and 5 FTE hours for each subsequent review.
- 9 Required by the new revisions to the Adequate Public Facilities Manual for priority development projects.
- 11 Under our current program, this process is comprised of two-steps: request for a change and the physical change to the plan, if the request is approved. The request for a change is forwarded to the Planning Director and reviewed by a minimum of three staff persons prior to completion. The careful review and decision whether to support or not to support a request is determined by reviewing the current easement(s), features in that easement(s) and the proposed replacement. Staff has reviewed recent requests and determined that the average staff time spent to process these requests warrants the creation of this fee.
- 13 The is a new fee that is being implemented to recover staff cost for reviewing Site Design and Architectural Review requirements on previously built structures.
- 15-23 Our staff inspectors conduct Zoning Inspections for this permit type and we currently do not charge a fee for that inspection. This new fee will recover staff cost for conducting these inspections.
- 25 This is a new fee for the fees and charges listing. It is a fee that is invoiced to us from Planchek. Staff was previously collecting it under another fee category that was not correct. It is being added so this fee can be charged appropriately.
- 27 This is a new fee that allows us to collect a daily or weekly violation fee as outlined in the Building Code.
- 29 This fee is to support the amount of review time taken in the Critical Area. These cases included a separate set of criteria/findings that must be achieved to move forward. Additionally, close coordination with the Critical Area Commission is required by State law. On average, the review time for Critical Area Program compliance for these items is 2 FTE hours for the review.
- 31 There currently is no application fee for these permits. This is to cover administrative costs for review.
- 32 A decision has been made to charge a fee for this inspection because the work was being done without compensation for this type. Fee follows the consistent \$60 charge.
- 34-39 The county has not purchased property to relocate a new citizen disposal area and mulching operations. Until a new facility is operational with scales; flat rates will need to be established for commercial yard waste and pickup truck and car transactions. The yard waste flat rate will be utilized once operations relocate. The recycling center bulk rate would be assessed once construction begins on cell 4. To avoid customer confusion, we are limiting the recycling center new kiosks' fee options. Suggesting to establish only one flat rate (\$15) for pick-up trucks and cars at the centers.
